

**RESOLUTION AMENDING THE RULES AND REGULATIONS FOR  
THE VALLEY AT WINTER PARK WATER DISTRICT**

**WHEREAS**, the Board of Directors (“Board”) of the Valley at Winter Park Water District (“District”) has the power and authority pursuant to Section 32-1-1001(1)(m) C.R.S., to adopt and/or amend Rules and Regulations not in conflict with the Constitution and the laws of this State for carrying on the business, objects and affairs of the Board and of the District; and

**WHEREAS**, the Board adopted its current Rules and Regulations on December 8, 2016; and

**WHEREAS**, after proper notice to all customers as required by Section 32-1-1001(2)(a) C.R.S., deliberation at a public meeting held as publicized in such notice, the Board has determined that it is in the best interest of the District, its residents and customers, and the public health, safety, and welfare to amend the District’s Rules and Regulations as further described below.

**NOW THEREFORE BE IT RESOLVED** by the Board of Directors of the Valley at Winter Park Water District, Grand County, Colorado, as follows:

**Section 1. Amendment to Rules and Regulations.** The Rules and Regulations of the District, which are incorporated herein by this reference, are amended by the increase of service charges in Appendix A – Schedule of Fees and Charges as described below and in Table A-1 of Appendix A:

\$100.00 per hour for requested service work during normal workday hours of 8:00 am through 5:00 pm;

\$130.00 per hour for requested service work on Saturdays or at times other than normal workday hours of the workweek;

\$150.00 per hour for requested service work on Sundays and designated holidays.

**Section 2. Legal Holidays Designated by the District.** The District hereby designates as legal holidays for which the highest service rate shall apply, the following:

New Years Day;

Presidents Day;

Memorial Day;

Independence Day;

Memorial Day;

Independence Day;

Labor Day;

Thanksgiving Day;

Christmas Day.

3. **Interpretation.** The District reserves the right to change or rescind the adopted Rules and Regulations at any time, and in addition, reserves the right to determine the meaning, purpose, and effect of the Rules and Regulations based upon operating experience, generally accepted engineering standards, and practices and rules of textual interpretation.

4. **Severability.** If any part or provision of the Rules and Regulations is adjudged to be unenforceable or invalid, such judgment shall not affect, impair, or invalidate the remaining provisions of this Resolution, it being the Board's intention that the various provisions hereof are severable.


5. **Effective Date.** The provisions of this Resolution shall take effect immediately.
